Submission Requirements

If the borrower submitted a loan forgiveness application to its PPP lender before December 27, 2020, then this form must be completed and submitted to your PPP Lender not later than January 26, 2021. If your PPP lender has already submitted a forgiveness decision to SBA, the PPP lender must promptly transmit the completed SBA Form 3508D to SBA via email at pppforgivenessrequests@sba.gov. Otherwise, your PPP lender must transmit the completed SBA Form 3508D to SBA via the Paycheck Protection Platform when the PPP lender issues its forgiveness decision to SBA. If the borrower submits a loan forgiveness application to its PPP lender on or after December 27, 2020, this form must be completed and submitted to your PPP Lender within 30 days after submitting the forgiveness application. In that case, your PPP lender must transmit the completed SBA Form 3508D to SBA via the Paycheck Protection Platform when the PPP lender issues its forgiveness decision to SBA. Privacy Act (5 U.S.C. 552) – The information provided in this form is protected by the Privacy Act, 5 U.S.C 552a, which prohibits the federal government from disclosing personal information about an individual without the individual's consent.
